Sub:- Elections to Members (Co-opted), Chairperson and Vice-Chairperson of Zilla Praja Parishad and Member (Co-opted), President and Vice-President of Mandal Praja Parishad – Procedural instructions – Typographical error in the Note given under format of Form-B - Corrected - Reg.

In the reference cited, the State Election Commission issued procedural instructions in connection with the elections to Members (Co-opted), Chairperson and Vice-Chairperson of Zilla Praja Parishad and Member (Co-opted), President and Vice-President of Mandal Praja Parishad and also prescribed formats for appointment of whip, direction of whip, Form-A and Form-B. Instructions were given in the said circular under Paragraph VI that Form-A / Form-B should be submitted to the Presiding Officer concerned before 10:00 AM on the day of election as specified in Rule 10(1) and 21(1) of the relevant rules issued in G.O. 1st cited. However, in the format of Form-B appended to the said circular, at Point No. 1 of the Note given under the said format, there was a typographical error mentioning the time as "11:00 AM on the day of election" instead of "**10:00 AM on the day of election**".

In view of the above, the following correction shall be made to Point No. 1 under Note of the format of Form-B appended to the Circular 2nd cited.


