In the references 4<sup>th</sup> to 7<sup>th</sup> cited, the State Election Commission issued orders for conduct of indirect elections to the offices of Mayors/Deputy Mayors of Municipal Corporation, Chairpersons/Vice-Chairpersons of Municipalities/Nagar Panchayats, Presidents/Vice-Presidents of Mandal Praja Parishads and Chairpersons/Vice-Chairpersons of Zilla Praja Parishads in Andhra Pradesh State on 03.07.2014 (Municipal Bodies), on 04.07.2014 (MPPs) and on 05.07.2014 (ZPPs).

Detailed procedural instructions were given in the references 1<sup>st</sup> to 3<sup>rd</sup> cited in connection with the elections to the said offices including formats for appointment of whip and Form-A and Form-B. The recognised political parties shall submit the prescribed forms to the Presiding Officers concerned before the deadline fixed in the rules and reiterated in the circular instructions. The forms related to appointment of whip in Annexure-I and II shall be submitted to the Presiding Officers concerned before 11:00 AM on the day preceding the day of election. Form-A / Form-B shall be submitted to the Presiding Officer concerned before 10:00 AM on the day of election.
