ORDER:

The State Election Commissioner has issued notification to hold 4th Ordinary Elections to the office of Sarpanch and Ward Members of Gram Panchayats 2013 in Phased manner on 23.07.2013, 27.07.2013 and 31.07.2013 in the State.

2. In this connection elaborate arrangements have to be made for the setting up of polling stations, supply of ballot boxes, police bandobust, distribution of ballot papers and other materials etc., for which a large number of motor vehicles are required for use by the officers working under the direction of the District Collectors. The Government have therefore decided that all the Government vehicles available should be utilized for this purpose. Accordingly all District Collectors except Hyderabad District in the State are authorized to requisition the required number of Government vehicles with immediate effect till the date of election process is completed and utilize them for election work. The following vehicles are however exempted keeping in view the importance of work in those departments.

1. Vehicles belonging to Police and Fire service.
2. Vehicles of TRANSCO and GENCO actually engaged in operation systems
3. Vehicles donated by bodies like UNICEF etc.
4. Vehicles supplied to extension service centres in extension service, department of Training Colleges.
5. Vehicles actually engaged in the areas where epidemic diseases are prevalent.
6. Vehicles belonging to Rural Water Supply and Rig division.

3. All the Heads of Departments and District Officers are requested to get their vehicles repaired wherever it is found necessary from their respective departmental budget and keep them in good condition and spare them to the District Collectors as and when requisitioned.

4. The cost of fuel for the vehicles requisitioned may be met from out of the funds released by Government for election purpose.
