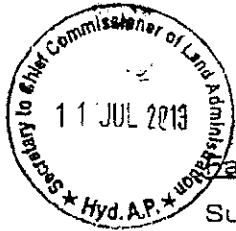

The attention of the Chief Commissioner of Land Administration, Hyd is invited to the references cited and he is informed that in the reference 1st cited the Secretary to State Election Commission has requested the Government to issue necessary instructions to all the Revenue authorities competent to issue community Certificates to process applications filed up to the last date of making nominations, i.e.,13.7.2013 expeditiously and if possible to instruct them to issue Community Certificates manually through their respective offices besides through Mee-Seva Centers and also to direct him to keep their offices open and attend to this work on 13.7.2013 also being a public holiday on account of Second Saturday.

In the reference 2nd cited the CCLA , Hyd has already issued instructions to all the District Collectors in the State to permit the competent authorities to entertain the applications and issue Castes Certificate manually till the Nomination process is over for the ensuring Panchayat Elections.

The Chief Commissioner of Land Administration, Hyderabad is hereby requested to direct all the District Collectors to open the offices of the Tahsildars in the State on 13.07/2013 being a public holiday on account of 2nd Saturday, to issue Community Certificates and to complete the process.
