The attention all the District Election Officers (except Hyderabad) is invited to the reference first cited and they are informed that the State Election Commissioner in his letter second cited has stated that instructions were issued from the office of the CEO vide reference first cited to all the Collectors & DEOs to supply hard and soft copy of Assembly Electoral Rolls published w.r.t. 1.1.2011 to prepare Gram Panchayat Electoral Rolls for publication as per statute and conduct of elections to P.R.Bodies that were due in July-August, 2011. However, the elections were postponed due to protracted Court litigation. He has further stated that now the Hon'ble Supreme Court of India in its interim direction dt.18.02.2013 issued orders to proceed with the elections to P.R.Bodies, that as the electoral rolls of Gram Panchayats are to be prepared adopting the latest Assembly Electoral Rolls published with reference to 01.01.2013 as qualifying date and the District Panchayat Officers are authorized to prepare and publish the electoral rolls of Gram Panchayats, he has requested to issue instructions to all the Collectors and District Election Officers (except Hyderabad) to provide soft and hard copies of photo electoral rolls published with reference to 01.01.2013 as qualifying date to the DPOs of their respective districts as per the yardstick as was done last time.

2. In view of the above request, all District Election Officers (except the Hyderabad) are, therefore, requested to provide the photo electoral roll published on 15.01.2013 with reference to 01.01.2013 along with the supplements prepared under continuous updation till date

as detailed below, to all the District Panchayat Officers in their districts under proper acknowledgement and intimation to this office as well as to the State Election Commission duly complying with the guidelines issued by the Election Commission of India vide its letter dt.10.12.2008 (copy enclosed).

- (ii) One CD containing the above Assembly photo electoral rolls in pdf format
- (iii) Password-free electoral roll database with photographs in digital format


