Sub:- Elections – 4th Ordinary elections to PR Bodies – Preparation, publication and printing of Gram Panchayat photo electoral rolls with reference to 01.01.2013 as qualifying date – Further instructions - Issued – Reg.

Ref:- 1) Circular No.91/SEC-B2/2013 dated 23.02.2013.

In continuation of the procedural instructions issued in the Circular cited, the following further instructions are issued on the above subject.

1) In Govt. Memo.No.648/Elecs.E/A2/2013-1, dated 22.2.2013 the Chief Electoral Officer, A.P. issued instructions to the District Election Officers to provide the Assembly photo electoral rolls published on 15.01.2013 with reference to 1.1.2013 as qualifying date along with the supplements prepared under continuous updations till date. Such supplements prepared under continuous updation contain inclusions, deletions and corrections ordered after final publication of Assembly Electoral Rolls on 15.01.2013 till date. The inclusions, deletions and corrections contained in such supplements shall also be integrated in the Gram Panchayat photo electoral rolls prepared with reference to 1.1.2013 as qualifying date.

2) It was already clarified in SEC Fax Message No.194/SEC-B2/2006-10, dated 12.4.2006, that clerical or printing errors in Assembly electoral rolls like indication of wrong gender against names of electors need not be reproduced in the Gram Panchayat photo electoral rolls and correct gender need to be indicated in the Gram Panchayat photo electoral rolls. Gender may be corrected if the photo and name is matching. but the gender is not matching eg., i). name of a male and photo of a male but gender mentioned as female; ii). name of a female and photo of a female but gender is

mentioned as male. Such printing errors should be brought to the notice of the AERO and MRO concerned to take steps to get them corrected in Assembly electoral rolls also.

3) A CD containing password free gram panchayat photo electoral roll data with reference to 1.1.2013 as qualifying date in respect of all Gram Panchayats in each district shall be sent to SEC and CPR to display it in their respective website. It can also be displayed in district website. Search facility should also be provided on the lines of one that exists in the Chief Electoral Officer's website (www.ceoandhra.nic.in) with regard to Assembly rolls.

4) With regard to format of Gram Panchayat photo electoral rolls prescribed in SEC circular No.118/SEC-B2/2011-2, dated 7.3.2011, some of the Dist. Panchayat Officers sought some clarification with regard to age and gender. To save space, the following modifications are permitted.

- 1) The entry relating to age can be printed as 'వయస్సు:' instead of "1.1.2013 నాటికి వయస్సు" and at the bottom of each page 'వయస్సు లెక్కింపు తేదీ:' 1.1.2013" shall be printed.
- 2) With regard to gender: in case of male the entry can be "లింగము:పు" and in case of female the entry can be "లింగము: స్త్రీ"
