### NOTIFICATION

**Date: 27.07.2013**

Whereas, the State Election Commission issued a Notification in Ref. No. 757/SEC-B2/2013, dated 03.07.2013 for conduct of ordinary elections to Gram Panchayats in the State and also notified election programme in connection therewith;

And whereas, in respect of Kondapur Gram Panchayat in Chandur Mandal in Nalgonda District, the Returning Officer Stage-I published the list of contesting candidates on 17.07.2013 after 3:00 PM for all the offices of Sarpanch and Ward Members of the said Gram Panchayat and the poll was scheduled on 27.07.2013;

And whereas, the Collector & DEA, Nalgonda District reported that it has come to light at the time of conduct of poll on 27.07.2013 that the Returning Officer Stage-I has not included the name of a candidate, who stood validly nominated and also not withdrawn his candidature in the list of contesting candidates published in Form-9 for election to Ward Member of Ward No. 7 of Kondapur Gram Panchayat and requested the Commission to issue instructions;

And whereas, the election process of Ward No. 7 of the said Gram Panchayat was vitiated from the stage of publication of list of contesting candidates due to the above mentioned error and therefore it is necessary to renotify the election programme for the said Ward from the stage of publication of list of contesting candidates;

Now, therefore, in exercise of the powers conferred under Article 243K of the Constitution of India, Section 200 of the A.P. Panchayat Raj Act, 1994 and Rule 7 of the A.P. Panchayat Raj (Conduct of Elections) Rules, 2006, the State Election Commission, hereby, renotifies the election programme for Ward No. 7 of Kondapur Gram Panchayat in Chandur Mandal of Nalgonda District from the stage of publication of list of contesting candidates as shown below.


1.	Publication of list of contesting candidates (for Ward No. 7)	28.07.2013 (3:00 PM)
2.	Dates of Poll (for Ward No. 7)	03.08.2013 (From 7:00 AM to 1:00 PM)
3.	Date of Counting	03.08.2013 (From 2:00 PM onwards)
4.	Declaration of Result	Soon after the completion of counting of votes

The Collector & DEA, Nalgonda shall also initiate disciplinary action against the Returning Officer Stage-I of the said Gram Panchayat for the serious irregularity he committed in connection with election to Ward No. 7 of the said Gram Panchayat. The Collector & DEA, Nalgonda shall proceed with the election process of Sarpanch and all Wards, except Ward No. 7, of the said Gram Panchayat on 27.7.2013 as per the schedule already notified by the Commission in the Notification No. 757/SEC-B2/2013, dated 03.7.2013. The election of Upa-Sarpanch of the said Gram Panchayat shall be conducted on 03.08.2013 after declaration of the result of Ward No. 7 in pursuance of this notification.
