Whereas, the State Election Commission issued a Notification in Ref. No. 757/SEC-B2/2013, dated 03.07.2013 for conduct of ordinary elections to Gram Panchayats in the State and also notified election programme in connection therewith;

And whereas, the Poll is conducted in 3 Phases Revenue Division-wise as per the details given in the Annexure-II of the Notification referred to above on 23.07.2013, 27.07.2013 and 31.07.2013;

And whereas, incessant rains caused floods in major rivers and streams and marooned several villages damaging roads and communication network in some Districts and the State Election Commission decided to reschedule the date of Poll and subsequent election process in the flood affected Gram Panchayats based on the report sent by the Collectors and District Election Authorities of the affected Districts;

And whereas, the Collectors and District Election Authorities of Adilabad, East Godavari, Karimnagar, Khammam, Nizamabad and Warangal sent reports to the Commission seeking rescheduling of poll process and subsequent election process in the flood affected Gram Panchayats indicated in the Annexure appended to this Notification and requesting to postpone Poll to a later date;

And whereas, Rule 7 of the A.P. Panchayat Raj (Conduct of Elections) Rules, 2006 empowers the State Election Commission to alter the election programme of any Panchayat or Panchayats either generally or in respect of specified Panchayats for valid reasons, such as natural calamities, floods, etc., and to renotify election programme as deemed fit in the circumstances of the case and the Returning Officer shall give effect to the same;

Now, therefore, in exercise of the powers conferred under Article 243K of the Constitution of India, Section 200 of the A.P. Panchayat Raj Act, 1994 and Rule 7 of the A.P. Panchayat Raj (Conduct of Elections) Rules, 2006, the State Election Commission, hereby, alters election programme already notified in the Notification No. 757/SEC-B2/2013, dated 03.07.2013 so far as it relates to the Gram Panchayats indicated in the Annexure appended to this Notification and renotifies the altered election programme from the stage of conduct of Poll synchronizing it with the 3rd Phase of Poll as shown below:
