Whereas, the State Election Commission issued a Notification in Ref. No. 757/SEC-B2/2013, dated 03.07.2013 for conduct of ordinary elections to Gram Panchayats in the State and also notified election programme in connection therewith;

And whereas, in pursuance of the said Notification, the Returning officer concerned has issued Election Notice on 09.07.2013 for conduct of elections to Varadarajulapalle Gram Panchayat of Yadamari Mandal in Chittoor District;

And whereas, the Addl. District Election Authority and DPO, Chittoor in his Letter No.460-10/2013 A6(Ele), dated 24.07.2013 reported that Sri M. Mohan Reddy, S/o. Jejula Reddy, a contesting candidate for 3rd Ward of Varadarajulapalle Gram Panchayat expired on 23.07.2013 and the Returning Officer (Stage-2) countermanded the poll and going ahead with the conduct of elections for the post of Sarpanch as well as remaining Ward Members;


And whereas, it is stipulated under the said rule 17(1) that where the poll is countermanded, the election proceedings shall be started afresh in all respects as if for a new election provided that no fresh nomination shall be necessary in case of a candidate who stood validly nominated at the time of countermanding of the poll;

Now, therefore, in exercise of the powers conferred under Article 243-K of the Constitution of India and Rule 17(1) of the A.P. Panchayat Raj (Conduct of Elections) Rules, 2006, the State Election Commission, hereby, notifies the fresh election programme for conduct of election to Ward Member of the 3rd Ward of Varadarajulapalle Gram Panchayat in Yadamari Mandal of Chittoor District in the Annexure appended to this notification.


