**NOTIFICATION**

**No.757/SEC-B2/2013-4**

**Date: 30.07.2013**

Whereas, the State Election Commission issued a Notification in Ref. No. 757/SEC-B2/2013, dated 03.07.2013 for conduct of ordinary elections to Gram Panchayats in the State and also notified election programme in connection therewith;

And whereas, in pursuance of the said Notification, the Returning officer concerned has issued Election Notice on 09.07.2013 for conduct of elections to Vanthadpula Gram Panchayat in Narsimhulapet Mandal of Warabgal District;

And whereas, the Collector & DEA, Warangal in his Letter No.ECR/17/2013, dated 23.07.2013 reported that Smt. Kanchenapally Roja, W/o. Naganna, a contesting candidate for the office of Sarpanch, Vanthadpula Gram Panchayat in Narsimhulapet Mandal died of electrocution on 22.07.2013 and under Rule 17(1) of A.P. Panchayat Raj (Conduct of Elections) Rules, 2006 the poll to the office of Sarpanch of the said Gram Panchayat was countermanded and the date of poll and subsequent election process of Ward Members was postponed;


And whereas, under Section 14(2) of the A.P. Panchayat Raj Act, 1994, the election to the office of Sarpanch may be held at the same time and at the same place as ordinary elections of the Members of the Gram Panchayat;

And whereas, it is stipulated under the said rule 17(1) that where the poll is countermanded, the election proceedings shall be started afresh in all respects as if for a new election for the countermanded post of Sarpanch provided that no fresh nomination shall be necessary in case of a candidate who stood validly nominated at the time of countermanding of the poll;

Now, therefore, in exercise of the powers conferred under Article 243-K of the Constitution of India, Section 14(2) of the A.P. Panchayat Raj Act, 1994 and Rule 17(1) of the A.P. Panchayat Raj (Conduct of Elections) Rules, 2006, the State Election Commission, hereby, notifies the fresh election programme for the office of Sarpanch, rescheduled date of poll for all the Wards and subsequent election process in Vanthadpula Gram Panchayat in Narsimhulapet Mandal of Warangal District, in the Annexure appended to this notification.


