The Collector and District Election Authorities shall be responsible for providing sufficient number of polling stations and for the publication of list of polling stations for conduct of elections to MPTCs/ZPTCs. Instructions were issued in references 1<sup>st</sup>, 2<sup>nd</sup> and 4<sup>th</sup> cited on setting up of polling stations for conduct of elections to MPTCs/ZPTCs.

The list of polling stations for conduct of elections to MPTCs/ZPTCs were published between 6.4.2013 and 17.4.2013 based on electoral rolls of MPPs/ZPPs published with reference to 1.1.2013 as qualifying date as per the orders issued in reference 3<sup>rd</sup> cited.

The State Election Commission issued notification on 07.03.2014 for publication of electoral rolls of Gram Panchayats, Mandal Praja Parishads and Zilla Praja Parishads with reference to 1.1.2014 as qualifying date for conduct of ordinary elections to MPTCs/ZPTCs to comply with the directions of the Hon'ble Supreme Court to notify elections by 10.03.2014.

Now, therefore, the State Election Commission hereby issues the following schedule for republication of list of polling stations for conduct of elections to MPTCs/ZPTCs based on electoral rolls of GPs, MPPs and ZPPs to be published with reference to 1.1.2014 as qualifying date on 10.03.2014.
