NOTIFICATION

Under Section 153(3) of Andhra Pradesh Panchayat Raj Act, 1994, the first meeting of the Mandal Praja Parishad shall be called after the publication of results of ordinary elections to elect President and Vice-President.

The State Election Commission issued order in Ref.No.1505/SEC-B1/2014-8, dated 31.07.2014 for conduct of elections to the offices of Presidents and Vice-Presidents of Mandal Praja Parishads in Khammam District indicated in the Annexure on 06.08.2014 after declaration of results of 4th ordinary elections.


Under Section 153(5) of the said Act, the term of office of President and Vice-President, who is elected at an ordinary election, shall be five years from the date appointed by the State Election Commission for the first meeting of the Mandal Praja Parishad after the ordinary elections.

Under Section 154(ii) of the said Act, a member elected at an ordinary election and a Co-opted member shall hold office for a term of five years from the date appointed by the State Election Commissioner for the first meeting of the Mandal Praja Parishad after the said ordinary elections.

Now, therefore, in exercise of the powers conferred under Section 153(5) and Section 154(ii) of the Andhra Pradesh Panchayat Raj Act, 1994, the State Election Commissioner, hereby, appoints 06.08.2014 (that is the date fixed by the Commission for conduct of election of Presidents and Vice-Presidents vide Order dtd.31.07.2014) as the date of first meeting after ordinary elections in respect of the Mandal Praja Parishads in Khammam District indicated in the Annexure for the purpose of commencement of term of office of Members, President and Vice-President of the said Mandal Praja Parishads.
