**NOTIFICATION**

Under Section 153(3) of Andhra Pradesh Panchayat Raj Act, 1994, the first meeting of the Mandal Praja Parishad shall be called after the publication of results of ordinary elections to elect President and Vice-President.

The State Election Commission issued order in Ref.No.1515/SEC-B1/2014-1, dated 26.06.2014 for conduct of elections to the offices of Presidents and Vice-Presidents of all Mandal Praja Parishads in Ananthapur, Chittoor, East Godavari, Guntur, Krishna, Kurnool, Prakasam (except Martur MPP), SPSR Nellore, Srikakulam, Visakhapatnam, Vizianagaram, West Godavari and YSR District on 04.07.2014 after declaration of results of 4<sup>th</sup> ordinary elections to MPPs.

Under Section 153(5) of the said Act, the term of office of President and Vice-President, who is elected at an ordinary election, shall be five years from the date appointed by the State Election Commission for the first meeting of the Mandal Praja Parishad after the ordinary elections.

Under Section 154(ii) of the said Act, a member elected at an ordinary election and a Co-opted member shall hold office for a term of five years from the date appointed by the State Election Commissioner for the first meeting of the Mandal Praja Parishad after the said ordinary elections.

Now, therefore, in exercise of the powers conferred under Section 153(5) and Section 154(ii) of the Andhra Pradesh Panchayat Raj Act, 1994, the State Election Commissioner, hereby, appoints 04.07.2014 as the date of first meeting of all the Mandal Praja Parishads in Ananthapur, Chittoor, East Godavari, Guntur, Krishna, Kurnool, Prakasam (except Martur MPP), SPSR Nellore, Srikakulam, Visakhapatnam, Vizianagaram, West Godavari and YSR District for which 4<sup>th</sup> ordinary elections were held for the purpose of commencement of term of office of Members, President and Vice-President of the said Mandal Praja Parishads.
