**NOTIFICATION**

In exercise of the powers conferred by Sections 200 and 201 of the Andhra Pradesh Panchayat Raj Act, 1994, (Act 13 of 1994) read with and Andhra Pradesh Conduct of election of Co-opted Member, President and Vice-President of Mandal Parishad and Co-opted Members, Chairperson and Vice-Chairperson of Zilla Parishad Rules, 2006 issued in G.O.Ms.No. 173, PR & RD (Elems) Dept, dated 10.5.2006, the State Election Commissioner, hereby, directs any gazetted officer of the Government authorised by the District Collectors and District Election Authorities of **Prakasham and YSR districts** to conduct election to the casual vacancies of **Vice-President of Mandal Praja Parishads** indicated in Annexure-I in accordance with the procedure laid down in the said Rules and specifies the schedule for election to the said office in the Annexure-II appended to this Notification.

It is stipulated under Rule 9(2) of the said rules that where election of President or Vice-President of Mandal Praja Parishad could not be conducted in the first two meetings convened for the purpose for want of quorum, President / Vice-President shall be elected in the subsequent meeting or meetings convened for the purpose from among the members present without insisting for quorum.

As election to the office of Vice-President of Mandal Praja Parishads covered in this notification could not be conducted in the two special meetings convened earlier for this purpose for want of quorum, election of Vice-President shall be held in the special meeting convened in pursuance of this notification without insisting for quorum.


