Sub: Elections – 4<sup>th</sup> Ordinary Elections to MPTCs / ZPTCs – MPTC Cherlagudem in Sangareddy MPP of Medak District – Use of 150 ballot papers of another MPTC (MPTC Pothireddypally) for conduct of poll process in Polling Station No.43 of MPTC Cherlagudem - Fresh poll ordered for MPTC election only – Reg.

In the reference cited, it is reported that in Polling Station No. 43 of MPTC Cherlagudem in Sangareddy MPP of Medak District, the poll process was conducted for sometime using ballot papers pertaining to another MPTC (MPTC Pothireddypally) and it was noticed after nearly 150 ballot papers of another MPTC were polled. The poll process in Polling Station No. 43 of MPTC Cherlagudem was vitiated due to the above error or irregularity which falls within the scope of 225C of A.P. Panchayat Raj Act, 1994.

After taking all material circumstances into account, the State Election Commission in exercise of the powers conferred under Section 225C of the A.P. Panchayat Raj Act, 1994, hereby, declare the poll conducted on 06.04.2014 in Polling Station No.43 of MPTC Cherlagudem in Sangareddy MPP of Medak District as void and also direct that a fresh poll shall be taken up in Polling Station No.43 of MPTC Cherlagudem for election to MPTC only on 11.04.2014 from 7:00 AM to 5:00 PM duly following the procedure prescribed under A.P. Panchayat Raj (Conduct of Elections) Rules, 2006. No fresh poll is required for election to ZPTC Sangareddy in the said Polling Station No.43.

The Collector and District Election Authority, Medak and the Returning Officer concerned shall inform the contesting candidates in writing, give wide publicity in the polling areas concerned and also in the print and electronic media.

In the fresh poll to be conducted on 11.04.2014, indelible ink shall be applied on the left middle finger of the voters.
