**ORDER**

The State Election Commission issued order in Ref.No.1505/SEC-B1/2014-1, dtd.26.6.2014 for conduct of elections to the offices of Member (Co-opted), President and Vice-President of Mandal Praja Parishads at 11:00 AM on 04.7.2014 and if election is not held for any reason to any of the said offices on 04.7.2014 to hold it at 11:00 AM on 05.7.2014.

As per the information furnished by the Collectors & District Election Authorities concerned, election to the offices of President/Vice-President of Mandal Praja Parishad indicated in Annexure-I could not be conducted on 04.7.2014 and 05.7.2014 due to lack of quorum.

In such cases, the State Election Commission is empowered to fix another date for holding election to the offices of President / Vice-President under Rule 8(3) of Andhra Pradesh Conduct of Election of Member (Co-opted), President and Vice-President of Mandal Praja Parishad and Members (Co-opted), Chairperson and Vice-Chairperson of Zilla Praja Parishad Rules, 2006.

Now, therefore, the State Election Commission hereby directs the Collectors & District Election Authorities concerned to authorise a Gazetted Officer of the Government for each Mandal Praja Parishad indicated in Annexure-I to conduct election to the offices of President/Vice-President in accordance with the procedure laid down in the said rules and specifies the schedule for election to the said offices in the Annexure-II appended to this order.


Under Rule 9(2) of the said rules, where the election of President or Vice-President of Mandal Praja Parishad could not be conducted in the first two special meetings convened for the purpose for want of quorum, the President or Vice-President shall be elected in the subsequent meeting/meetings convened for the purpose from among the members present without insisting for quorum.

As election of President / Vice-President of Mandal Praja Parishad indicated in the Annexure-I could not be conducted in the first two special meetings convened for the purpose on 04.7.2014 and 05.7.2014 for want of quorum, election to the said offices shall be held in the special meetings convened in pursuance of this order without insisting for quorum.




