**ORDER**


The State Election Commission issued Orders in Ref.No.1505/SEC-B1/2014-8, dtd.31.07.2014 for conduct of elections to the offices of Member (Co-opted), President and Vice-President of (39) Mandal Praja Parishads in Khammam District on 06.08.2014.

The Collector and District Election Authority, Khammam in his report in Ref.No.EC/1078/2014, dtd.06.08.2014 informed the Commission that elections to the office of Member (Co-opted), President and Vice-President of Raghunadhapalem, Kothagudem and Palvancha MPPs could not be conducted on 06.08.2014 due to lack of quorum and non-receipt of nominations for the office of Member (Co-opted) and requested to fix a fresh schedule for conduct of elections to the said (3) Mandal Praja Parishads.

Now, therefore, the State Election Commission, hereby, directs the Collector and District Election Authority, Khammam to authorise a Gazetted Officer of the Government each for Raghunadhapalem, Kothagudem and Palvancha Mandal Praja Parishads to conduct election of Member (Co-opted), President and Vice-President in accordance with the procedure laid down in the Andhra Pradesh Conduct of Election of Member (Co-opted), President and Vice-President of Mandal Praja Parishad and Members (Co-opted), Chairperson and Vice-Chairperson of Zilla Praja Parishad Rules, 2006 and specifies the schedule in the Annexure to this Order.



- 2.** After completion of election of Member (Co-opted), if for any reason the election of President and Vice-President of Mandal Praja Parishad is not held on the date fixed above i.e., 13.08.2014, it shall be held at 3.00 PM on the next day, i.e., 14.08.2014 whether or not it is observed as holiday by the Mandal Praja Parishad concerned.
