ORDER

The State Election Commission issued orders in Ref.No.1515/SEC-B1/2014-1, dtd.26.6.2014 for conduct of indirect elections to the offices of Member (Co-opted), President and Vice-President of Mundlamur Mandal Praja Parishad along with others on 04.7.2014.

The State Election Commission issued orders in Ref.No.1515/SEC-B1/2014, dtd.03.7.2014 for stoppage of all further proceedings in connection with conduct of election to the said offices in Mundlamur MPP on 04.7.2014 due to litigation in Hon'ble High Court in WP No. 15415 of 2014.

Now, the Hon'ble High Court, on the request of the counsel for the petitioner seeking permission of the Hon'ble Court to withdraw the WP, dismissed the said WP as withdrawn and also ordered that all miscellaneous petitions pending shall stand dismissed vide its orders dtd.09.7.2014.

Now, therefore, the State Election Commission, hereby, directs the Collector and District Election Authority, Prakasam to authorise a Gazetted Officer of the Government to conduct election to the offices of Member (Co-opted), President and Vice-President of Mundlamur Mandal Praja Parishad in accordance with the procedure laid down in the Andhra Pradesh Conduct of Election of Member (Co-opted), President and Vice-President of Mandal Praja Parishad and Members (Co-opted), Chairperson and Vice-Chairperson of Zilla Praja Parishad Rules, 2006, and specifies the schedule for the elections to the said offices in the Annexure appended to this order.
