**ORDER:**

Prameela Devi, Assistant Section Officer (Admn) shall continue to assist the PIO and APIO. The Joint Secretary & Secretary (FAC), APSEC is the Appellate Authority. The contact details of the officers designated under RTI Act, 2005 are furnished in 4(1)(b) information, which is placed on the official website of APSEC ([www.apsec.gov.in](http://www.apsec.gov.in)).

The PIO and APIO shall submit periodical reports to the Government and A.P. Information Commission. All the officers and staff of APSEC are directed to render all assistance to the above officers in order to provide timely information to the persons seeking information from APSEC under RTI Act, 2005.
