Under Rule 4(1) of the said rules, the State Election Commissioner also hereby directs that ward-wise **photo electoral rolls** of the Municipal Corporations concerned shall be prepared in the same format as the Assembly electoral rolls. The details of the polling areas shall be indicated on the title page.
