Sub: State Election Commission – 4th Ordinary elections to Municipal Bodies, 2014 – Elections notified for (10) Municipal Corporations and (146) Municipalities / Nagar Panchayats on 03.03.2014 – Orders under sections 60-A of GHMC Act, 1955 and 28-E of AP Municipalities Act, 1965 specifying use EVMs for giving and recording votes by EVMs in the elections – Reg.

WHEREAS, sections 60-A of the Greater Hyderabad Municipal Corporation Act, 1955 and 28-E of Andhra Pradesh Municipalities Act, 1965 provide for giving and recording of votes by voting machines in such manner as may be prescribed, may be adopted in such Ward or Wards as the State Election Commission may, having regard to the circumstances of each case, specify;

AND WHEREAS, the State Election Commission has considered the circumstances in all the Wards in the (10) Municipal Corporations and (146) Municipalities and Nagar Panchayats notified for election on 03.03.2014 vide Notifications cited and is satisfied that sufficient number of Electronic Voting Machines are available for taking the poll in all the Wards in the (10) Municipal Corporations and (146) Municipalities and Nagar Panchayats notified for election, the polling personnel well trained in efficient handling of Electronic Voting Machines and the electors are also conversant with the operation of Electronic Voting Machines;

NOW, THEREFORE, the State Election Commission in exercise of the powers conferred under sections 60-A of the Greater Hyderabad Municipal Corporation Act, 1955 and 28-E of Andhra Pradesh Municipalities Act, 1965, hereby specifies that in all the Wards of (10) Municipal Corporations and (146) Municipalities and Nagar Panchayats notified for election vide Notifications cited, votes shall be given and recorded by means of Electronic Voting Machines in the manner prescribed under the A.P. Municipal Corporations (Conduct of Election of Members) Rules, 2005 and A.P. Municipalities (Conduct of Election of Members) Rules, 2005 and the supplementary instructions issued by the State Election Commission from time to time on the subject.
