Sub: Elections - 4th ordinary elections to Municipal Corporations – Publication of List of Polling Stations in Eluru, Vijayawada, Nellore, Chittoor, Kadapa and Ananthapur Municipal Corporations where earlier schedule was hampered due to strike by Government employees – Fresh schedule – Issued – Reg.

The State Election Commission issued detailed Circular instructions in the reference 1st cited with regard to setting up of Polling Stations and their publication in connection with conduct of ordinary elections to Municipal Corporations. In the reference 3rd cited, certain amendment was issued to the Circular instructions issued in the reference 1st cited.

In the reference 2nd cited, the State Election Commission issued schedule for publication of Polling Stations in all Municipal Corporations in the State, except GHMC and Guntur Municipal Corporation, commencing from 01.08.2013 and ending with final publication on 12.08.2013. However, the process of publication of list of Polling Stations was hampered in Eluru, Vijayawada, Nellore, Chittoor, Kadapa and Ananthapur Municipal Corporations due to agitation by Government employees in Coastal Andhra and Rayalaseema Regions in the wake of announcement of Telangana State as per the report given by the Commissioner & Director of Municipal Administration in the reference 4th cited.

Now, therefore, the following schedule is fixed for publication of list of Polling Stations in Eluru, Vijayawada, Nellore, Chittoor, Kadapa and Ananthapur Municipal Corporations.

1. Preparation of ward-wise draft list of polling stations : 04.11.2013
2. Publication of ward-wise list of polling stations in draft : 05.11.2013
by the concerned Returning Officer
3. Time for receipt of objections and suggestions : 06.11.2013 to
07.11.2013
4. Meeting with the representatives of political parties : 08.11.2013
5. Submission of the ward-wise draft list of polling : 11.11.2013
stations by the Returning Officer to the Commissioner
of Municipal Corporation concerned
6. Approval of the Commissioner of Municipal Corporation : 12.11.2013
for the ward-wise list of polling stations
7. Final publication of the ward-wise list of polling stations : 13.11.2013

The process of publication of polling stations shall be completed as per the schedule given above and a compliance report shall be sent to the Commission soon after completion along with necessary statistical information.
