All the contested candidates of Municipal Corporations, Municipalities and Nagar Panchayats are required to furnish their final election expenditure returns, as specified in relevant Acts and Rules, to the concerned Collector & District Election Authority within 45 days from the date of declaration of results i.e. on or before 26-06-2014 through the Commissioner of concerned Municipal Corporation / Municipality / Nagar Panchayat as the case may be. The date of submission of the final return in the office of concerned Municipal Commissioner shall be deemed to be the date of filing of return.

Further you are requested to send the information of candidates who furnished the return within stipulated time as per law in Proforma – A and information of defaulters in Proforma – B appended to this letter to the Commission soon after completion of the stipulated 45 days time i.e. **26-06-2014.**
