**NOTIFICATION**

The State Election Commission issued Notification in Ref.No.86/SEC-F2/2014, dated 03.03.2014 for conduct of 4<sup>th</sup> Ordinary Elections to (146) Municipalities and Nagar Panchayats in the State. Subsequently, election process of Banaganapally Nagar Panchayat was stopped in pursuance of the orders of the Hon'ble High Court setting aside orders issued by the Government on constitution of Banaganapally Nagar Panchayat.

As per the election schedule notified by the Commission in the said Notification dated 03.03.2014, the poll was conducted on 30.03.2014 and counting of votes was scheduled for 02.04.2014.

The State Election Commission issued a Notification in Ref.No.86/SEC-F2/2014-2, dated 01.04.2014 rescheduling the date of counting and declaration of results in respect of all (145) Municipalities and Nagar Panchayats to 09.04.2014 instead of 02.04.2014 in compliance of the orders passed by the Hon'ble High Court dated 01.04.2014 in PIL Nos. 94 and 97 of 2014.

The said orders of the Hon'ble High Court dated 01.04.2014 were challenged in the Hon'ble Supreme Court of India in SLP (C) No.9610/2014 and the Hon'ble Court passed interim orders on 04.04.2014 that result of election to the Municipal Bodies shall not be published and posted the matter on 07.04.2014.


The Hon'ble Supreme Court of India in its order dated 07.04.2014 in SLP (C) No.9610/2014 directed that the counting of votes and declaration of results of Municipal elections shall be taken up after completion of 2<sup>nd</sup> Phase of Poll of General Elections to APLA and HOP scheduled for 07.05.2014.

Now, therefore, in compliance of the said orders of the Hon'ble Supreme Court dated 07.04.2014, the State Election Commission, hereby, postpones the date of counting of votes and declaration of results in respect of (145) Municipalities and Nagar Panchayats which was scheduled to take place on 09.04.2014 to a date to be notified later, which will be any date after 07.05.2014.

All the Election Officers shall give effect to these orders.
