ORDER

The State Election Commission issued order in Ref.No.1501/SEC-F2/2014, dtd.26.6.2014 directed the Collector & District Election Authority, YSR District to authorise a Gazetted Officer of the Government to conduct elections to the offices of Chairperson and Vice-Chairperson of Jammalamadugu Nagar Panchayat along with other Municipalities / Nagar Panchayats on at 11:00 AM on 03.7.2014 and if election is not held for any reason to any of the said offices on 03.7.2014 to hold it at 11:00 AM on 04.7.2014.

The Collector & DEA, YSR District authorised the RDO, Jammalamadugu to act as Presiding Officer to conduct election to the offices of Chairperson and Vice-Chairperson of Jammalamadugu Nagar Panchayat.

As per the reports received from the Presiding Officer on 04.7.2014, the election to the said offices of Chairperson and Vice-Chairperson of Jammalamadugu Nagar Panchayat could not be conducted on 03.7.2014 and 04.7.2014 due to disturbances inside the venue of the special meeting and law and order problem.

The State Election Commission, after careful consideration of the matter, decided to fix a fresh schedule for conduct of election authorizing an experienced and competent officer to conduct the special meeting for the purpose of conduct of election to the said offices in Jammalamadugu Nagar Panchayat.

Now, therefore, the State Election Commission hereby directs the Collector & District Election Authority to authorise the Joint Collector, YSR District to conduct election to the offices of Chairperson and Vice-Chairperson of Jammalamadugu Nagar Panchayat in accordance with the procedure laid down in Andhra Pradesh Municipalities (Conduct of Election of Chairperson and Vice-Chairperson) Rules, 2005 and specifies the schedule for election to the said offices in the Annexure appended to this order.

The State Election Commission also directs the Collector & DEA and the Superintendent of Police to camp at Jammalamadugu to personally supervise law and order situation and take such steps as deemed fit in order to ensure that the election process is completed in a free, fair and peaceful environment as per schedule now fixed in this order.
