**ORDER**

The State Election Commission issued order in Ref.No.1517/SEC-F2/2014, dtd.26.6.2014 for conduct of elections to the offices of Chairperson and Vice-Chairperson of certain Municipalities and Nagar Panchayats at 11:00 AM on 03.7.2014 and if election is not held for any reason to any of the said offices on 03.7.2014 to hold it at 11:00 AM on 04.7.2014.

As per the information furnished by the Collectors & District Election Authorities of Nalgonda and Medak Districts, election to the offices of Chairperson/Vice-Chairperson of Municipalities and Nagar Panchayats indicated in the Annexure-I could not be conducted on 03.7.2014 and 04.7.2014 due to lack of quorum.

As per Rule 5 of Andhra Pradesh Municipalities (Conduct of Election of Chairperson and Vice-Chairperson) Rules, 2005, the State Election Commission is empowered to fix another date for holding election to the said offices in such cases.

Now, therefore, the State Election Commission hereby directs the Collectors & District Election Authorities concerned to authorise a Gazetted Officer of the Government for each Municipality / Nagar Panchayat indicated in Annexure-I to conduct election to the offices of Chairperson/Vice-Chairperson in accordance with the procedure laid down in Andhra Pradesh Municipalities (Conduct of Election of Chairperson and Vice-Chairperson) Rules, 2005 and specifies the schedule for election to the said offices in the Annexure-II appended to this order.

Under Rule 5 of the said rules, where the election of Chairperson or Vice-Chairperson could not be conducted in the first two special meetings convened for the purpose for want of quorum, the Chairperson or Vice-Chairperson shall be elected in the subsequent meeting/meetings convened for the purpose from among the members present without insisting for quorum.

As election of Chairperson/Vice-Chairperson of the Municipalities/Nagar Panchayats indicated in the Annexure-I could not be conducted in the first two special meetings convened for the purpose on 03.7.2014 and 04.7.2014 for want of quorum, election to the said offices shall be held in the special meetings convened in pursuance of this order without insisting for quorum.
