The attention of all the District Election Officers is invited to the reference first cited, wherein it was requested to provide the photo electoral roll published on 15.01.2013 with reference to 01.01.2013 along with the supplements prepared under continuous updation till 25.05.2013 to the Municipal Commissioners in their districts. Accordingly, the data base till 25.05.2013 has been provided by the respective DEOs / EROs to the Municipal Commissioners concerned.

2. Now, the Secretary, State Election Commission vide reference second cited has requested to issue necessary instructions to all the DEOs and EROs having jurisdiction over the urban local bodies in the State to provide soft and hard copies of supplements till date so as to enable the Municipal Commissioner to prepare electoral rolls to be published on 25.07.2013 and also to provide such database with photographs only upto the date of election notification to be issued by the Commission to the Municipal Commissioners concerned.

3. The electoral roll database under continuous updation is not available with the Districts, as the online ERMS is being implemented and they cannot copy the same at their level. Hence, the supplemental data as on 23.07.2013 is being extracted and placed on ftp along with check lists. The data as on 25.07.2013 will be placed on ftp on 26.07.2013.

4. All the District Election Officers are, therefore, requested to download the database of supplements of additions, deletions, modifications prepared under continuous updation from 26.05.2013 till 23.07.2013 and 25.07.2013 along with the check lists and to supply the same to the Municipal Commissioners under proper acknowledgement under intimation to this office as well as to the State Election Commission.
